China says US trade sanctions on Hong Kong violate WTO rules

BELIJING — Washington's decision to strip Hong Kong of its special trading status violates rules of the World Trade Organization, China said Thursday.

President Donald Trump announced Friday that the US will revoke special trading privileges

granted to Hong Kong, after Beijing moved to tighten its grip on the semi-autonomous city with plans to impose a national security law. Removing the special status would affect a bilateral extradition treaty, commercial relations and export controls between

the US and the Asian financial hub. The move adds to growing friction between the world's two biggest economies amid the coronavirus crisis and in the wake of a two-year trade war that has not been fully resolved. Commerce ministry spokesman Gao Feng

said the special trading status given to the former British colony was recognised by all WTO members and did not depend solely on the United States.

"If the United States disregards the fundamental principles of international relations and adopts uni-

lateral measures according to its domestic laws, it will violate WTO rules and will not be in the interest of the United States," Gao added at a regular press briefing.

A spokesman of China's banking regulator said separately that Hong Kong's status as a finan-

cial hub will not be shaken by the potential sanctions. "Hong Kong's financial market is running smoothly... and there is no abnormal capital outflow", said the spokesman, adding that this reflects the international market's confidence in the city.—AFP ■

The announcement for Electrical and Electronic Equipment (EEE) products to be manufactured and traded in accordance with (50) Myanmar Electrical and Electronic Standards

1. ASEAN Electrical and Electronic Mutual Recognition Arrangement (EE MRA) was signed by ASEAN Economic Ministers on 5th April 2002 to support the implementing of ASEAN Economic Community (AEC) by Implementing the agreement for cooperation in Electrical and Electronic Sector. According to EE MRA, the test report and Certificate of Conformity (CoC) issued by one of the ASEAN member states shall be accepted by other member states when trading Electrical and Electronic Equipment (EEE) products with low voltage power supply rating of between 50 and 1000 V ac and between 75 and 1500 V dc within ASEAN member states, in order to avoid re-testing in Imported country, to manufacture and trade according to harmonized standards and to be safety.
2. The agreement on the ASEAN Harmonised EEE Regulatory Regime (AHEEERR) was signed on 9th December 2005 by Economic Ministers of Member States in order to implement the activities of EEMRA.
3. In accordance with EEMRA and AHEEERR activities, suppliers who are interested to Import regulated EEE products of ASEAN member states to Myanmar must import EEE products which have been tested at ASEAN listed Conformity Assessment Bodies (CABs) to be compliance with the ASEAN Harmonised Standard and regulated standards of respective country. And the supplier must be registered those EEE products at Directorate of Industrial Supervision and Inspection (Electrical Inspection Department) with Test report and Certificate of Conformity (CoC) before distribution in the Market.
4. Likewise, the manufacturer who are interested to export regulated EEE products to ASEAN member states must manufacture EEE in compliance with ASEAN Harmonised Standards and regulated standards of imported country. And these products shall be exported along with the test report and Certificate of Conformity attested by the ASEAN listed Conformity Assessment Bodies (CABs)
5. Therefore, Ministry of Planning, Finance and Industry hereby Inform to all EEE products manufacturers, suppliers and consumers that the EEMRA and AHEEERR activities [implementing by Directorate of Industrial Supervision and Inspection (Electrical Inspection Department)] will be in effect as of 2021 with following (50) Myanmar EEE Standards
