APPLICATION FOR THE IMPOSITION OF DUMPING DUTY IN RESPECT OF ALUMINIUM ZINC COATED STEEL EXPORTED TO AUSTRALIA FROM TAIWAN

I am writing to notify you that the Anti-Dumping Commission (the Commission) has received a properly documented application requesting the publication of a dumping duty notice in respect of exports of aluminium zinc coated steel having width equal to or greater than to 600 mm exported to Australia from Taiwan. The goods are classified to the following tariff classifications and statistical codes:

- 7210.61.00 statistical codes 60, 61 and 62;
- 7225.99.00 statistical code 39.

The Commission is currently assessing the matters raised in the application to determine if the application appears to establish reasonable grounds for the publication of a dumping duty notice. Pursuant to Article 5.5 of the World Trade Organization *Anti-Dumping Agreement*, the Commission is avoiding any publicising of the application.

Australian legislation requires that a decision on whether to proceed with an investigation must be made on or before 29 June 2020, unless extended as a result of further information being provided to the Commission by the applicant. I will inform you of the outcome of the Commission consideration of the application as early as possible.

Should a decision be made to initiate the investigation, you will be provided with a copy of the non-confidential version of the application.
