主旨：有關菲律賓關稅委員會頃發布進口浮式明板及色板玻璃防衛措施正式調查報告一案，請查照。

說明：

- 一、依據菲律賓關稅委員會(Tariff Commission)本(109)年6月30日函(詳附件1)辦理；本組本年2月10日台菲經字第1090704050號函諒達。
- 二、上函檢附之正式調查報告(詳附件2)指出，本案調查期間(102年至106年)進口之浮式明板及色板玻璃雖導致菲國內業者之市占率下降、浮式明板玻璃獲利率衰退及浮式色板玻璃庫存增加，惟整體而言，上述產品進口量之增加對菲國內產業並未構成嚴重損害，未來短期內菲國浮式明板及色板玻璃之進口量應不會持續增加。關稅委員會已終結本案調查，並提交調查報告予貿工部，建議該部無須針對進口之浮式明板及色板玻璃採取最終防衛措施。
- 三、依據菲國防衛措施法令，貿工部應於收到關稅委員會正式調查報告15日內，由貿工部部長裁定是否實施最終防衛措

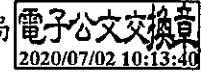
