# NOTIFICATION UNDER ARTICLE 12.1(A) OF THE AGREEMENT ON SAFEGUARDS ON INITIATION OF AN INVESTIGATION AND THE REASONS FOR IT

#### **PHILIPPINES**

High-Density Polyethylene and Linear Low-Density Polyethylene pellets and granules

The following notification, dated 4 September 2020, is being circulated at the request of the delegation of the Philippines.\*

Further to Article 12.1 (a) of the WTO Agreement on Safeguards, the Permanent Mission of the Philippines to the WTO hereby notifies the Committee on Safeguards of the initiation of a preliminary safeguard investigation on the importation of High-Density Polyethylene (HDPE) and Linear Low-Density Polyethylene (LLDPE) pellets and granules from various countries.

#### 1 DATE OF INITIATION OF THE INVESTIGATION

Notice of initiation of preliminary safeguard investigation was published on 4 September 2020.

#### 2 PRODUCT SUBJECT TO THE INVESTIGATION

HDPE pellets and granules classified under ASEAN Harmonized Tariff Nomenclature (AHTN) Code 3901.20.00 and LLDPE pellets and granules classified under AHTN Codes 3901.10.12, 3901.10.92, 3901.40.00 and 3901.90.90.

#### **3 REASONS FOR INITIATION OF INVESTIGATION PROCEDURE**

The investigation was initiated on the basis of the petition submitted by the petrochemical industry represented by JG Summit Petrochemical Corporation (JGSPC) that increased imports of High-Density Polyethylene (HDPE) and Linear Low-Density Polyethylene (LLDPE) pellets and granules cause serious injury to the domestic industry in terms of declining domestic sales, production, utilization rate, reduction in labor productivity, incurred losses, suppression, depression and increase inventory.

The investigation has been initiated to determine whether safeguard measures are warranted.

NOTICE OF THE INITIATION OF A PRELIMINARY INVESTIGATION ON THE APPLICATION FOR SAFEGUARD MEASURES ON THE IMPORTATION OF HIGH-DENSITY POLYETHYLENE (HDPE) AND LINEAR LOW-DENSITY POLYETHYLENE (LLDPE) PELLETS AND GRANULES FROM VARIOUS COUNTRIES (SG CASE NOS. SG05-2020 & SG06-2020)

Notice is hereby given that the Department of Trade and Industry has officially received properly documented applications from JG Summit Petrochemical Corporation (JGSPC) for the imposition of safeguard measures on the importation of High-Density Polyethylene (HDPE) and Linear Low-Density Polyethylene (LLDPE) pellets and granules from various countries. The applications allege that HDPE and LLDPE are being imported into the country in increased quantities as to be a substantial cause of serious injury to the local industry.

The Department acting under Section 6 of RA 8800, the Safeguard Measures Act, reviewed the evidence adduced in the application and has determined the existence of a prima facie case to justify the initiation of preliminary investigations. The products covered by the investigations are HDPE pellets and granules classified under AHTN Code 3901.20.00, and LLDPE pellets and granules classified under AHTN Codes 3901.10.12, 3901.10.92, 3901.40.00 and 3901.90.90. The period of investigation (POI) covers the years 2015 to 2019.

Rule 5.2 of the Implementing Rules and Regulations (IRR) of RA 8800 provides that "the Secretary when establishing that the application of a safeguard measure will be in the public interest shall take into consideration the following factors; among others: (i) whether the imposition of the provisional measure will result in political and economic crisis: and (ii) the extent to which such imposition will cause a shortage of a product under consideration in the domestic market".

WHEREFORE, IN VIEW THEREOF, interested parties are invited to submit their views on the matter, including on whether the imposition of a safeguard measure on the aforementioned products is in the public interest. Submissions may be made to the Bureau of Import Services (BIS), Department of Trade and Industry, 3<sup>rd</sup> Floor, Tara Building, #389 Senator Gil Puyat Avenue, Makati City, or through electronic submission to bis\_irmd@dti.gov.ph within five (5) days from the date of publication of this notice.
