主旨: RR-2019-002 / Carbon Steel Screws / Order and Reasons

On October 28, 2019, the Canadian International Trade Tribunal issued a notice of expiry review informing all interested parties that it was initiating an expiry review of its order made on January 5, 2015, in Expiry Review No. RR-2014-001, continuing, with amendment, its order made on January 6, 2010, in Expiry Review No. RR-2009-001, continuing, with amendment, its finding made on January 7, 2005, in Inquiry No. NQ-2004-005, concerning the dumping of certain carbon steel screws originating in or exported from the People's Republic of China and the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu, and the subsidizing of such products originating in or exported from the People's Republic of China. This notice was published in Part I of the November 9, 2019, edition of the *Canada Gazette*.

The Tribunal has now completed its expiry review pursuant to subsection 76.03(3) of the *Special Import Measures Act (SIMA)*. Therefore, in accordance with paragraph 76.03(12)(b) of *SIMA*, the Tribunal has made an order. Enclosed is a copy of the order and statement of reasons, in English.
