二、ITC於本(6)月23日公告旨揭產業損害調查終判結果：

(一)ITC裁定商務部先前認定我國、韓國、泰國廠商構成傾銷以及越南廠商接受補貼之本案產品，對於美國產業造成實質損害。

(二)商務部稍後將對於我國等3國本案產品發布反傾銷稅命令，並對於越南產品發布平衡稅命令。(謹註，本案商務部於本年5月24日發布反傾銷調查最終認定，我商反傾銷稅率為正新橡膠20.04%，南港輪胎101.84%，其他廠商84.75%。美國2020年自我國進口涉案產品金額約4.38億美元。)

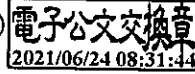

PASSENGER VEHICLE AND LIGHT TRUCK TIRES FROM KOREA, TAIWAN, AND THAILAND, AND SUBSIDIZED PASSENGER VEHICLE AND LIGHT TRUCK TIRES FROM VIETNAM, INJURE U.S. INDUSTRY, SAYS USITC

The United States International Trade Commission (USITC) today determined that a U.S. industry is materially injured by reason of imports of passenger vehicle and light truck tires from Korea, Taiwan, and Thailand that the U.S. Department of Commerce (Commerce) has determined are sold in the United States at less than fair value and subsidized by the government of Vietnam.

The Commission further found that imports of these products from Vietnam that Commerce has determined are sold in the United States at less than fair value are negligible and voted to terminate the antidumping duty investigation concerning Vietnam.

Chair Jason E. Kearns, Vice Chair Randolph J. Stayin, and Commissioners Rhonda K. Schmidlein and Amy A. Karpel voted in the affirmative with respect to the antidumping duty investigations involving Korea, Taiwan, and Thailand and the countervailing duty investigation concerning Vietnam. They made a finding of negligibility with respect to the antidumping duty investigation involving Vietnam.



Commissioner David S. Johanson voted in the negative with respect to the antidumping duty investigations involving Korea, Taiwan, and Thailand and the countervailing duty investigation concerning Vietnam. He made a finding of negligibility with respect to the antidumping duty investigation involving Vietnam.

As a result of the Commission's affirmative determinations, Commerce will issue antidumping duty orders on imports of these products from Korea, Taiwan, and Thailand, and a countervailing duty order on imports of these products from Vietnam. As a result of the finding of negligibility, the antidumping duty investigation regarding imports of these products from Vietnam will be terminated.

The Commission's public report *Passenger Vehicle and Light Truck Tires from Korea, Taiwan, Thailand, and Vietnam* (Inv. Nos. 701-TA- 647 and 731-TA-1517-1520 (Final), USITC Publication 5212, July 2021) will contain the views of the Commission and information developed during the investigations. FACTUAL HIGHLIGHTS

Passenger Vehicle and Light Truck Tires from Korea, Taiwan, Thailand, and Vietnam
Investigation Nos. 701-TA-647 and 731-TA-1517-1520 (Final)

Product Description: Passenger vehicle and light truck tires (PVLТ tires) are new pneumatic tires of rubber, designed principally for highway use on standard passenger cars, sport utility and crossover vehicles, vans and light trucks. Subject tires are primarily of tubeless steel-belted radial ply design, sold in the 13- to 26-inch rim diameter range to original equipment manufacturers or in replacement markets. PVLТ tires, tube or tubeless, radial or non-radial, produced domestically or imported must conform to applicable motor vehicle safety standards of the National Highway Traffic Safety Administration (NHTSA), Department of Transportation (DOT), including the "DOT" symbol on subject tire sidewalls. Excluded from the scope are tires absent the DOT symbol, certain off-the-road, spare, and trailer tires, used or retreaded tires, or non-pneumatic tires such as solid rubber tires, and specifications outside of the *Tire and Rim Association Year Book*.
