NOTIFICATION UNDER ARTICLE 12 OF THE AGREEMENT ON SAFEGUARDS

The following communication, dated and received on 21 October 2021, is being circulated at the request of the delegation of Ukraine.

On 24 July 2020, the Interdepartmental Commission on International Trade (hereinafter referred to as the Commission) took the decision No. SP-458/2020/4411-03 "On initiation and conduction of safeguard investigation on imports to Ukraine of wires regardless of country of origin and export" (G/SG/N/6/UKR/19 of 09 September 2020, G/SG/N/6/UKR/19/Corr.1 of 21 September 2020).

Pursuant to Article 12.1(b) of the Agreement on Safeguards, Ukraine notified on finding a serious injury or threat thereof to the domestic industry producing wires and on proposed safeguard measures (G/SG/N/8/UKR/11 - G/SG/N/10/UKR/11 - G/SG/N/11/UKR/9 of 31 March 2021).

On 23 April 2021, the Commission took the decision No. SP-491/2021/4411-03 "On application of safeguard measures on imports to Ukraine of wires regardless of country of origin and export". Notice of the decision was published in the official newspaper "Uryadovyi Courier" No. 176 of 14 September 2021(<u>https://bit.ly/2YHddX3</u>).

On 24 September 2021 in accordance with Article 16.12 of the Law of Ukraine "On the application of safeguard measures for imports into Ukraine" the Commission took the decision No. SP-508/2021/4411-03 "On conduction of review of the decision of the Commission of 23 April 2021 No. SP-491/2021/4411-03 ('On application of safeguard measures on imports to Ukraine of wires regardless of country of origin and export')".

Notice of the decision was published in the official newspaper "Uryadovyi Courier" No. 186 of 25 September 2021 (<u>https://bit.ly/3mLSEAF</u>).

Following the above review, the Commission took the decision of 11 October 2021 No. SP-510/2021/4411-03 "On revocation of the decision of the Commission of 23 April 2021 No. SP-491/2021/4411-03 ('On application of safeguard measures on imports to Ukraine of wires regardless of country of origin and export')".
