
主旨：有關菲律賓關稅委員會發布高密度聚乙烯防衛措施正式調查報告一案，請查照。

說明：

- 一、依據菲律賓關稅委員會主席Marilou P. Mendoza本(111)年6月29日致本處徐大使佩勇函辦理。
- 二、旨揭調查報告指出，菲國自國外進口之高密度聚乙烯顆粒與國內生產之高密度聚乙烯顆粒屬同類產品，且自2021年上半年起，自國外進口產品數量不論絕對值或相對國內生產值均增加，並對國內產業構成損害。目前雖非構成嚴重損害，惟倘菲國未實施最終防衛措施，將導致國內產業遭受立即性嚴重所害。菲律賓關稅委員會爰建議採取為期三年之最終防衛措施(謹註：我國未獲列微量豁免國家清單)，並已提交調查報告予貿工部，將由貿工部裁定是否實施最終防衛措施。
