主旨：印度通知針對異丙醇（Isopropyl alcohol, IPA）實施數量限制之防衛措施（如附件，WTO秘書處本（2023）年4月6日公布，文件代號G/SG/N/8/IND/33/Suppl.1），敬請查照。

說明：

- 一、相關文號：本團111年2月8日世貿字第1114340082號函。
- 二、根據旨揭通知，印度於上（2022）年2月7日通知會員擬採行針對IPA之進口數量限制（quantitative restriction, QR）措施（請參見說明一本團前函）後，繼根據防衛協定第12條第1項第C款，於本月6日通知會員針對IPA採行確定之國家別進口數量限制措施（country-wise QR）。
- 三、本次印方採行之QR措施自本年4月1日起，至2024年3月31日止；該期間內分四季（quarter）核配進口配額予相關出口會員（含我國），核配之數量請參見旨揭通知第4段附表。以上進口配額須根據以下條件實施：（一）為利以電子化

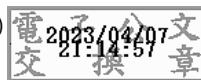


方式核配與及時監管配額，將僅透過電子資料交換（EDI）窗口核配；（二）自出口會員之進口量不得超過當季之獲配數量，故倘當季之進口量超過獲配配額量，超過之數量將自下一季之獲配量中扣減；（三）當季未使用之配額量將可延至下一季利用；（四）倘出口會員已使用完

（exhaust）獲配之進口量，在獲得印方通知後，得使用其它剩餘未利用之進口配額（available residual quantity）；及（五）倘有需要，印方將根據相關法規，另通知規範本案進口配額之進一步規定；印方並保留在任何時點，視需要檢討及更改本案防衛措施之權利。

The following communication, dated and received on 5 April 2023, is being circulated at the request of the delegation of India.

In continuation to WTO document G/SG/N/8/IND/33 - G/SG/N/10/IND/24 - G/SG/N/11/IND/19 dated 3 February 2022 notifying the finding of serious injury or threat thereof caused by increased imports of the product Isopropyl Alcohol (IPA), India notifies the final decision to impose definitive safeguard measure (Quantitative Restriction) on import of Isopropyl Alcohol.

1 PROVIDE EVIDENCE, CITING RELEVANT DATA AND THE APPLICABLE PERIOD OF INVESTIGATION OF SERIOUS INJURY OR THREAT THEREOF CAUSED BY INCREASED IMPORTS

4 PROVIDE PRECISE DESCRIPTION OF THE MEASURE

Import Policy condition on Isopropyl Alcohol has been amended from "free" to "country-wise quantitative restriction" (QR). The country-wise quantitative restriction (QR) for import of Iso Propyl Alcohol is as under:

The quantitative restrictions for import of IPA shall be subject to the following conditions:

- (i) Imports would be permitted through the Electronic Data Interchange (EDI) ports only to facilitate electronic/ real-time monitoring of QR;
- (ii) The QR would be monitored on quarterly basis;
- (iii) The total imports allowed in any quarter shall not exceed the total of that quarter and the next quarter. Accordingly, any excessively utilised QR for a quarter shall be deducted from the QR for the next quarter;
- (iv) Any unutilised QR for a quarter shall be added to next quarter;
- (v) In case, the countries with specific quantity exhaust their allocated QR, such countries may use the available residual quantity, as may be notified subsequently; and
- (vi) If necessary, further modalities will be notified separately governing such QR, in accordance with relevant legal provisions.

5 PROVIDE PROPOSED DATE OR ACTUAL DATE OF INTRODUCTION OF THE MEASURE AND EXPECTED DURATION OF THE MEASURE

The country-wise Quantitative Restrictions(QR) on import of Isopropyl Alcohol (IPA) have been notified for a period of one year i.e. 2023-24, effective from 01.04.2023 up to 31.03.2024 and will cease automatically on 31.03.2024. Further, India reserves the right to review and make any changes in the said safeguard measures at any point of time, as deemed fit.

6 IF THE NOTIFICATION RELATES TO A DECISION TO APPLY OR EXTEND A SAFEGUARD MEASURE, MEMBERS ARE ENCOURAGED TO PROVIDE THE FOLLOWING INFORMATION: (I) THE MAJOR EXPORTING MEMBERS OF IMPORTS OF THE PRODUCT INVOLVED

The product is being imported into India from various countries, with major quantities being imported from China PR, Korea RP, Singapore and Chinese Taipei.

(II) IF THERE ARE ANY EXPORTING MEMBERS TO WHICH THE MEASURE DOES NOT APPLY FOR ANY REASON OTHER THAN THE APPLICATION OF ARTICLE 9.1, THE NAMES OF SUCH EXPORTING MEMBERS AND REASONS FOR NON-APPLICATION OF THE MEASURE
