主旨:印尼通知延長針對「果糖糖漿」(Fructose Syrup)之防衛措施(如附件一,WTO秘書處本(2023)年6月26日公布之第G/SG/N/8/IDN/26/Suppl.2號文件),敬請查照。

說明:

- 一、相關文號:本團109年5月22日世貿字第10943404420號 函。
- 二、印尼在2020年5月19日曾以第G/SG/N/8/IDN/26號通知(請詳說明一本團前函)表示,自同年9月17日起針對旨揭產品實施為期3年之防衛措施。該措施係以從價稅(ad valorem duty)方式實施,稅率自第1年之24%,每滿1年調降2%,至第3年之20%。另根據印尼同年9月22日之第G/SG/N/8/IDN/26/Suppl.1號通知(如附件二),我國獲列入不被課徵之開發中國家名單中。
- 三、印方在本年6月26日透過WTO秘書處通知會員,表示根據其 自同年4月14日起展開之複查結果,將延長本措施3年,至






2026年9月16日止。延長後之第1年稅率為18%,第2年降至16%,第3年降至14%。依印方之通知所示,相關產品主要出口國是中國、土耳其、韓國及泰國;但其並未公布不列入課徵之列之開發中國家名單。本次複查之非機密版最終報告可自印尼之防衛委員會網站查獲下載:www.kppi.kemendag.go.id。

四、根據防衛協定第12條第3項,印尼政府提供與本案具實質出口利益會員諮商之機會。擬要求諮商之會員須依通知第13段所示,自本通知公布起7日內以書面向印尼之貿易部提出;諮商將透過視訊方式在本年7月7日前舉行。

NOTIFICATION UNDER ARTICLE 12.1(B) OF THE AGREEMENT ON SAFEGUARDS ON FINDING A SERIOUS INJURY OR THREAT THEREOF CAUSED BY INCREASED IMPORTS (EXTENSION OF THE EXISTING MEASURE)

The following communication, dated and received on 26 June 2023, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 7.2 and Article 12.1(b) of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia, hereby notifies the Committee on Safeguards the investigation findings concerning the extension of a safeguard measure against the importation of Fructose Syrup.

1 EVIDENCE THAT THE SAFEGUARD MEASURE CONTINUES TO BE NECESSARY TO PREVENT OR REMEDY SERIOUS INJURY OR THREAT THEREOF AND THAT THE INDUSTRY CONCERNED IS ADJUSTING

The Government of the Republic of Indonesia initiated an investigation on the extension of a safeguard measure on 14 April 2023 (G/SG/N/6/IDN/34/Suppl.1). The scope of the investigation was to decide whether the safeguard measure should be extended or not.

To determine whether the safeguard measure continues to be necessary to prevent or remedy serious injury or threat thereof and whether the industry is adjusting, the Investigating Authority (Komite Pengamanan Perdagangan Indonesia/KPPI) undertook a comprehensive analysis of a broad set of data from multiple sources: the evidence provided by the Applicant's member industries in their questionnaire replies and written submissions, the information provided by interested parties (users, importers, exporting producers and exporting country governments) in their written submissions, as well as information available to the Investigating Authority including statistical databases and relevant publications.

1.1 Economic performance of the Applicant

To assess the economic performance of the Applicant, the developments of imports, and other relevant data included in its assessment, the Investigating Authority assessed the data for the period 2020-2022 ('the investigation period').

- a) Although the Applicant's production has increased with a trend of 42.91% during the investigation period, this increase has not yet reached the predetermined production target with an average of 80%. Increased production aimed at production efficiency is one of the Petitioners' efforts in realizing the structural adjustment program.
- b) Domestic sales of the Petitioners experienced an increase with a trend of 42.81% during the investigation period. The increase in domestic sales has not reached the Applicant's sales target with an average of 80% due to several orders being canceled by customers.
- c) Productivity has increased during the investigation period with a trend of 44.45% but it had a negative impact on the trend of increasing production compared to the trend of decreasing number of employment.
- d) During the investigation period, the Applicant's Utilization Capacity showed an increase with a trend of 42.91% but only reached approximately 50% of the Applicant's target with an average of 80%. The target of Utilization Capacity was not achieved due to problems with the production machine system and delays in ordering by customers due to the COVID-19 pandemic.
- e) During the investigation period, the Applicant's profits decreased significantly with a trend of 98.19% This was due to the fact that the Applicant had to sell their product at a price below the production cost, which was caused by an increase in the price of the fructose syrup raw material.
- f) The number of Employment decreased with a trend of 1.07% during the investigation period. Even though there has been an increase in the number of Employment from 100 index points in 2020 to 106 index points in 2021, in 2022 there has been a reduction in the number of Employment to only 98 index points. This shows the potential for mass layoffs to occur in the future, if the imposition of safeguard measure on imported fructose syrup products is not extended.
- g) The Applicant's inventory continued to increase with a trend of 276.07% during the investigation period. Therefore, there is a cumulation of the Applicant's product in the storage warehouse, which causes an increase in storage costs and reduces the Applicant's profits or increases losses.

- a) During the investigation period, national consumption experienced a downward trend of 24.22%. due to the low demand for fructose syrup products from the domestic food and beverage industry.
- b) In the same period, the market share of imports also experienced a declining trend, but on the other hand, there was a significant increase in the share of imports from several countries that were exempted from the imposition of the safeguard measure.

c) During 2020-2022, the market share of the Applicant and Non-Applicants has increased even though the increase in 2021 was not as much as in 2020. The effectiveness of the safeguard measure was believed starting to diminish and therefore the Applicant has the potential to experience a threat of serious injury.

1.2 Evidence that the industry concerned is adjusting

The domestic industry has conducted adjustment plans aiming at increasing its technology, domestic sales target, marketing expansion, production efficiency, installed capacity, and additional Employment. The realization of the structural adjustment program that has been carried out by the Applicant is as follows:

Based on the table above, even though there was a decline in the amount of fructose syrup imports both in absolute and relative terms during the investigation period, the Applicant have so far been unable to prevent the threat of serious injury. This is clearly shown by the Applicant's profits during the investigation period which declined by 98.19%.

3 PRECISE DESCRIPTION OF THE PRODUCT INVOLVED

"Fructose Syrup, under the Indonesia Harmonized System (HS.) Code: 1702.60.20" in accordance with Indonesian Tariff Book (BTKI) 2022.

5 DESCRIPTION OF THE PROPOSED MEASURE

The proposed measure is in the form of ad valorem duty.

6 PROPOSED DATE OF INTRODUCTION OF THE MEASURE

The proposed extension of the safeguard measure will come into effect on 17 September 2023.

7 EXPECTED DURATION OF THE MEASURE

The expected duration of the proposed extension of the safeguard measure is three years.

8 PROPOSED DATE FOR THE REVIEW

Not applicable.

9 EXPECTED TIMETABLE FOR PROGRESSIVE LIBERALIZATION OF THE MEASURE

The measure will continue being progressively liberalized, at regular intervals, at the beginning of each period of application as follows:

10 IF THE NOTIFICATION RELATES ONLY TO A FINDING OF SERIOUS INJURY OR THREAT THEREOF, AND DOES NOT RELATE TO A DECISION TO APPLY OR EXTEND A SAFEGUARD MEASURE

Pursuant to Article 7.2 and Article 12.1(b) of the WTO Agreement on Safeguards, The Government of the Republic of Indonesia hereby notifies the investigation findings concerning the extension of safeguard measures against the importation of Fructose Syrup. This notification is made only for the findings of the investigation. Once the decision to extend the safeguard measure is made, it will be notified under Article 12.1(c) of the Agreement on Safeguards.

11 INFORMATION RELATING TO THE EXTENSION OF A SAFEGUARD MEASURE

11.1 Evidence that the industry concerned is adjusting and that the safeguard measure continues to be necessary to prevent or remedy threat of serious injury

Provided in item 1.

11.2 Reference to the WTO document that notified the initial application of the measure

Pursuant to Article 12.1(c) of the WTO Agreement on Safeguards, on 22 September 2020, The Government of the Republic of Indonesia notified the Committee on Safeguards regarding the decision to impose safeguard measures on the imports of Fructose Syrup on 22 September 2020 (G/SG/N/8/IDN/26/Suppl.1 - G/SG/N/10/IDN/26/Suppl.1 - G/SG/N/11/IDN/23).

11.3 Duration of the measure from initial application till the date at which it will be extended

The initial definitive safeguard measure is imposed for 3 years, from 17 September 2020 until 16 September 2023. The extension of the safeguard measure is proposed to be imposed for another 3 years, until 16 September 2026.

11.4 Precise description of the measure in place prior to the date of extension

The initial definitive measure was notified on 22 September 2020 (G/SG/N/8/IDN/26/Suppl.1 - G/SG/N/10/IDN/26/Suppl.1 - G/SG/N/11/IDN/23).

12 INFORMATION RELATING TO EXPORTING MEMBERS

12.1 The major exporting Members of imports of the product involved

The main exporting countries of the product concerned are the People's Republic of China, Türkiye, Republic of Korea and Thailand.

12.2 If there are any exporting Members to which the measure does not apply for any reason other than the application of Article 9.1, the names of such exporting Members and reasons for non-application of the measure

13 INVITATION OF CONSULTATIONS

Members who have a substantial interest in the Subject Goods shall submit a written request of consultation within a period of 7 days from the date of circulation of this notification. All written requests must be sent both in a written letter and in electronic format and must indicate the name, address, e-mail address, phone, and fax number of the Members.

In accordance with Article 12.3 WTO Agreement on Safeguard, the Government of the Republic of Indonesia is open for consultation in order to provide opportunities for those Members, consultation is scheduled to be held virtually no later than 7 July 2023.
