The following communication, dated and received on 6 September 2023, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 7.2 and Article 12.1(c) of the WTO Agreement on Safeguards, the Republic of Indonesia hereby notifies to extend the imposition of a safeguard measures in the form of specific safeguard duty on the importation of Subject Good, for a period of 3 (three) years by the issuance of Minister of Finance's Decree Number 75 Year 2023 dated 14 August 2023, promulgated in the Official Gazette of the Republic of Indonesia Year 2023 Number 646 on 22 August 2023.

A. GENERAL BACKGROUND

On 24 October 2022 the Republic of Indonesia notified the findings of investigation in which it was concluded that the relevant safeguard measure needs to be extended, in particular, to prevent or remedy serious injury suffered by the Applicant. The extension of such safeguard measures will also give the Applicant the opportunity to continue their adjustment program in order to improve the competitiveness of domestic industry ([G/SG/N/8/IDN/22/Suppl.1](#) - [G/SG/N/10/IDN/22/Suppl.2](#)).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia, to extend the imposition of a safeguard measures duty on the importation of the Subject Goods in the form of specific safeguard duty.

B. SUBJECT GOOD

"Evaporator in a type of roll-bond and fin that is part of refrigerators, freezers, and other refrigerating or freezing equipment", under Harmonized System (HS.) Code: Ex. 8418.99.10".

C. DESCRIPTION OF THE SAFEGUARD MEASURE

1. With reference to the proposal from the Investigating Authority, and taking into account the need to effectuate the safeguard measure as proposed and the relevant requirements

stipulated in the WTO Agreement on Safeguards, the Government of the Republic of Indonesia has decided to impose the following safeguard duty:

Timetable of the Safeguard Duty

Period	Safeguard Duty (%)
(5 September 2023 - 4 September 2024)	12.5
(5 September 2024 - 4 September 2025)	11
(5 September 2025 - 4 September 2026)	9.5
