<u>Subject</u>: Intimation under Rule 6 (5) of CVD Rules, regarding countervailing duty investigation concerning imports of Digital Offset Printing Plates" from China PR and Taiwan, and invitation for consultations under Article 13 of the WTO Agreement on Subsidies and Countervailing Measures.

The Directorate General of Trade Remedies ("DGTR") Ministry of Commerce and Industry, Government of India ("GOI"), presents its compliments to the Taipei Economic and Cultural Center in India and has the honour to draw its attention towards the application from the domestic producers in India for imposition of countervailing measures on imports of "Digital Offset Printing Plates" from China PR and Taiwan.

- 2. The applicant has inter alia alleged that producers/exporters of the above product from Taiwan are receiving significant countervailable subsidies as defined in the WTO agreement on subsidies and countervailing measures and such subsidized imports are causing or threatening to cause material injury to the domestic industry.
- 3. The Designated Authority hereby notifies the Taipei Economic and Cultural Center in India about the same in accordance with the Customs Tariff Act, 1975 read with Customs Tariff (Identification, Assessment and Collection of Countervailing Duty on Subsidized Articles and for Determination of Injury) Rules, 1995.
- 4. Additionally, pursuant to Article 13 of the WTO Agreement on Subsidies and Countervailing Measures, Taiwan is invited for consultations with the Government of India. Since the statutory deadline for initiation of the investigation is 30th September 2023, the Authority is required to take its decision on the same prior to the deadline. It is proposed that the consultations be held on 22nd September 2023. If Taiwan would like to have consultations with the Government of India, a written request for the same may be filed to the undersigned at the email ID mentioned below. This consultation would be in virtual mode and the meeting link for the same will be shared upon receipt of a formal request for consultations.

- 5. The attention of Taiwan is drawn to the fact that without prejudice to this opportunity for consultation, it may be noted that the process of consultation is not intended to prevent the authority from proceeding with the initiation of the investigation and further proceedings.
- 6. The Directorate General of Trade Remedies avails itself of this opportunity to renew to Taiwan the assurances of its highest consideration.
