說明：

一、依據印度商工部貿易救濟局(DGTR)本(2024)年1月12日第F. No. 7/20/2023-DGTR號及第F. No. 6/25/2023-DGTR號通知辦理(如附件)。

二、上函重點摘陳如次：

- (一)本案有關自對我國、中國大陸、韓國、越南及日本進口「數位平板印刷板」(Digital Offset Printing Plates)進行反傾銷稅落日複查，及對我國及中國大陸進口「數位平板印刷板」進行平衡稅案調查之產品定義(product control numbers, PCN)。
- (二)該局於2023年12月1日召開會議與相關利害關係人討論受調產品的PCN，各方對PCN的書面意見及上述會議中均建議界定為板材類型產品，要求維持與原始定義

Subject: Regarding PCN methodology and filing of questionnaire responses.

Reference:

- (i) Sunset review investigation of anti-dumping duties on imports of “Digital Offset Printing Plates” originating in or exported from China PR, Taiwan, Korea, Vietnam and Japan and**
- (ii) Anti-subsidy investigation on imports of “Digital Offset Printing Plates” originating in or exported from China PR and Taiwan.**

1. The sunset review of the existing anti-dumping duties and the anti-subsidy investigations were initiated vide notification nos. F. No. 7/20/2023-DGTR dated September 30, 2023, and F. No. 6/25/2023 dated September 29, 2023, respectively. Subsequent to the initiations, letters were sent to all the known interested parties containing details about various submissions, including the opportunity to submit their comments on the scope of the product under consideration (PUC) and propose product control numbers (PCNs), if any, within 15 days from the date of the said letters.
2. The Authority received comments from various interested parties regarding the finalization of the PCN methodology in the captioned investigations.
3. The Authority held a meeting on December 1, 2023, with the concerned interested parties for discussion on the scope of the PUC and PCN methodology in the sunset review investigation.
4. All the interested parties, in both their written comments on PCNs and the aforementioned meeting, have suggested adopting a PCN methodology based on the types of plates. Furthermore,

they have requested the adoption of the same methodology that was employed in the original investigation for the ongoing sunset review anti-dumping and anti-subsidy investigations.

5. In view of the comments received from the interested parties and discussion held during the meeting, the Authority adopts the following PCN methodology as mentioned below:

S. No.	PCN Parameter	Code
1	Computer-to-Conventional Plate (CtCP)/ UV Computer-to-Plate (UV CtP)	C
2	Thermal Plates	T
3	Violet Plates	V

6. Since the scope of the PUC is same in both the above referenced investigations, the Authority adopts the same PCN methodology, as indicated in Para 5, for both these investigations.
7. In view of the above, all the interested parties are requested to file their respective questionnaire responses for both the investigations in accordance with the above-mentioned PCN methodology **by 31st January 2024**. No extension of time will be given by the Authority to file the questionnaire responses.
8. This issues with the approval of the Designated Authority.
