**Subject: Regarding PCN methodology, filing of questionnaire responses and sampling of producers/exporters.**

**Reference: Anti-dumping investigation concerning imports of “Poly Vinyl Chloride Paste Resin” originating in or exported from China PR, Korea RP, Malaysia, Norway, Taiwan & Thailand**

1. The above referenced investigation was initiated vide notification no. F. No. 6/17/2023-DGTR dated September 30, 2023. Subsequent to the initiation, letters were sent to all the known interested parties containing details about various submissions, including the opportunity to submit their comments on the scope of the product under consideration (PUC) and propose product control numbers (PCNs), if any, within 15 days from the date of the said letters. No requests for extension of this timeline were received by the Authority.
2. The Authority received comments from various interested parties regarding the finalization of the PCN methodology in the captioned investigation.
3. The Authority held a meeting on December 1, 2023, with the interested parties who made submissions within the stipulated deadline for discussion on the scope of the PUC and PCN methodology in the subject investigation.
4. After examination of the comments received from the interested parties and discussion held during the meeting, the Authority adopts the PCN methodology as mentioned below:

5. In view of the above, all the interested parties are requested to file their respective questionnaire responses (QRs) in accordance with the above-mentioned PCN methodology **by 2nd February 2024.**
6. The specifics of any exclusion(s) are subject to determination throughout the investigation process and will be communicated in the final findings as deemed appropriate by the Authority. The Authority reserves the right to make the final decision based on the investigation's outcomes. Interested parties are, therefore, requested to file all the information in entirety.
7. Since a large number of interested parties have registered themselves in the instant investigation, the Authority may resort to sampling. The interested parties are requested to furnish their comments on the same along with the submissions of QRs.
8. This issues with the approval of the Designated Authority.
