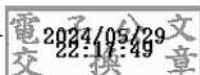

說明：

- 一、依據印度商工部貿易救濟局(DGTR)本(2024)年5月29日第 F. No. 22/4/2023-DGTR號函辦理(如附件)；本組本年5月10日竺經字第1130005158號諒蒙鈞察。
- 二、上開通知函重點略以，更正終判報告第29段及184段第6節，有關低灰冶金焦炭定義部分，原終判報告描述HS2704之灰分低於18%冶金焦實施數量限制(排除30mm、公差5%、磷含量低於0.03%，用於合金製造之焦粉/焦砂及超低磷冶金焦)，其中30mm規範原為「with size of 30 mm」，現修改為「with size upto 30 mm」。其餘終判報告內容未做修正。
- 三、以上各節，報請鑒察。

Corrigendum Notification
(Case No - SG (QR) - 04/2023)

Subject: Safeguard (Quantitative Restrictions) investigation concerning imports of Low Ash Metallurgical Coke into India.

Having regard to the Section 9A of Foreign Trade (Development and Regulation) Act, 1992 as amended from time to time and the Safeguard Measures (Quantitative Restrictions) Rules, 2012 thereof, as amended from time to time, the Authorised Officer has issued the Final Finding notification No. 22/4/2023 dated 29.04.2024 in respect of the Safeguard (Quantitative Restrictions) investigation concerning imports of Low Ash Metallurgical Coke into India.


Para 29 of the final findings notification to be read as under:

"Low Ash Metallurgical Coke, that is, Metallurgical Coke having ash content below 18% excluding coke fines / coke breeze and ultra-low phosphorous metallurgical coke with phosphorous content up to 0.030% with size **upto** 30 mm with 5% size tolerance for use in ferroalloy manufacturing."

Para 184 (vi) of the final findings notification to be read as under:

"Low Ash Metallurgical Coke, that is, Metallurgical Coke having ash content below 18% falling under the HS Code 2704 excluding coke fines / coke breeze and ultra-low phosphorous metallurgical coke with phosphorous content up to 0.030% with size **upto** 30 mm with 5% size tolerance for use in ferroalloy manufacturing."

All other aspects of the final finding notification No. 22/4/2023 dated 29.04.2024 issued by the Authorised Officer in respect of the subject Safeguard (Quantitative Restrictions) investigation remain unchanged.
