說明：

一、依據韓國貿易委員會（KTC）本（113）年6月5日英文信函辦理。

二、上揭來函略以：

（一）KTC依據1994年關稅及關貿總協定（GATT）第六條執行協定，通知台灣政府於2024年5月31日收到對來自台灣及中國之石油樹脂，要求啟動反傾銷調查之申請。涉案貨品之參考稅則號列為3911.10.1000（啟動調查後可能會改變）。

（二）KTC將於收到申請之日起兩個月內決定是否依據韓國關稅法施行令第60條展開調查。倘KTC決定展開調查，將通知相關出口國政府與供應商。

Dear Sir or Madam:

Article 5.5 of the Agreement on Implementation of Article VI of the GATT 1994 mandates the Investigation Authority to notify to the government of the exporting country the receipt of any application requesting the initiation of an antidumping investigation.

Accordingly, the Korea Trade Commission('the Commission') hereby informs the government of Taiwan that an application requesting the initiation of an antidumping investigation on Hydrocarbon Resin from the People's Republic of China and Taiwan was received on May 31, 2024.

For your information, Hydrocarbon Resin which are allegedly being imported into Korea at a dumped price, are currently classifiable into the subheading of 3911.10.1000 of the Harmonized Tariff System of Korea('the HSK'). However, this classification and the definition of subject merchandise are subject to change on or

after the initiation. The HSK subheadings are provided for convenience and Customs purpose only, and the written description of the subject merchandise is dispositive.

With regards to procedures ahead, the Commission will determine, within two months from the date of receipt of the application, whether to initiate an investigation in accordance with Article 60 of the Presidential Decree of the Customs Act of Korea. If the Commission determines to initiate an investigation, public notice will be given in the Korean Government Gazette and notification will be provided to the governments of the exporting countries and suppliers concerned.

We would like to stress that the determination on whether to initiate an investigation will be based on an unbiased and objective examination of the adequacy and accuracy of the evidence provided in the application.
