- 1. The Authority had initiated a countervailing duty investigation concerning imports of "Digital Offset Printing Plates" originating in or exported from China PR and Taiwan on 29.09.2023. As per Rule 7 (6) of the CVD Rules "The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing".
