Subject: The Final Determination of an Expiry Review of Anti-Dumping Measure on Imports of Certain Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel Originating in the People's Republic of China, the Republic of Korea and Taiwan and related Notifications.

Reference is made to the letter of the Department of Foreign Trade (DFT) No. 0309/2499 dated 13th September B.E. 2567 (2024) informing the Disclosure of the Essential Facts for the Draft Final Determination of an expiry review of anti-dumping measure on imports of Certain Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel Originating in the People's Republic of China, the Republic of Korea and Taiwan.

In this connection, the DFT would like to take this opportunity to further inform you that the Committee on Dumping and Subsidy has made the final determination to renew the AD measure on imports of Certain Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel Originating in the People's Republic of China, the Republic of Korea and Taiwan by applying AD duty at the rate of 0.00 – 29.50% of CIF for another 5 years. Please find the Notification of the Committee on Dumping and Subsidy regarding the Anti-Dumping Measure on Certain Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel Originating in the People's Republic of China, the Republic of Korea and Taiwan dated 3rd December 2024, announced in the Royal Thai Government Gazette on 19th December 2024, and related Notifications of the Department of Foreign Trade were also announced and publicized in the Royal Thai Government Gazette on 19th December 2024, from the QR Code below or visit <https://thaitr.dft.go.th/en/search/AD1022> under Section No. 8.2 for further information.
