

Final Affirmative Determinations in the Antidumping Duty Investigations of Dioctyl Terephthalate from Malaysia, Poland, Taiwan, and the Republic of Türkiye

On March 21, 2025, Commerce announced affirmative final determinations in the antidumping duty (AD) investigations of dioctyl terephthalate (DOTP) from Malaysia, Poland, Taiwan, and the Republic of Türkiye (Türkiye).
