The Designated Authority in the Directorate General of Trade Remedies (DGTR), Department of Commerce, Government of India, constituted to investigate anti-dumping matters, has received representations from the domestic industry in India, seeking initiation of the Anti-dumping investigation on dumped imports of Polyethylene Terephthalate film From Bangladesh, China, Taiwan, Thailand and United States of America, under the Customs Tariff Act, 1975, as amended from time to time read with Customs Tariff (Identification, Assessment and Collection of Anti-Dumping Duty on Dumped Articles and for Determination of Injury) Rules, 1995.
