**SUNSET REVIEW OF THE ANTI-DUMPING DUTIES ON POLYETHYLENE
TEREPHTHALATE ("PET") ORIGINATING IN OR IMPORTED FROM CHINESE
TAIPEI**

In accordance with the provisions in the Anti-Dumping Regulations (ADR), any definitive anti-dumping duty shall be terminated on a date not later than five years from the date of imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry, that the expiry of the duty would likely lead to the continuation and/or recurrence of dumping and/or subsidized exports and injury.

On **15 May 2026**, the International Trade Administration Commission of South Africa (ITAC) notified all interested parties, through **Notice No. 3932 of 2026** in **Government Gazette No. 54677**, that unless a duly substantiated request is made by or on behalf of the SACU industry, indicating that the expiry of the duty would likely lead to the continuation and/or recurrence of dumping and injury, the following anti-dumping duties will expire during 2027:

The Government of the Taiwan Republic of China is hereby notified of the above. Please note that the sections on procedural framework, confidential information, procedures and time limits are strictly applicable to all parties involved in the investigations above and should be regarded as incorporated herein.

ITAC is currently in the process of notifying all known manufacturers in the SACU of the subject products that a duly substantiated request must be made by or on behalf of the SACU industry, indicating that the expiry of the duty would likely lead to the continuation and/ or recurrence of dumping and/or subsidized exports and injury, on or before **08 March 2027**. In the instances where no replies are received from the SACU manufacturers within these time limits, the Commission will recommend the termination of the duties on the respective dates of expiry of the duties.

SACU manufacturers, who do submit a request timeously, are requested to subsequently submit duly substantiated information, indicating that the expiry of the duty would likely lead to the continuation and/or recurrence of dumping and injury, to the Commission, on or before the dates as specified below:

ITAC will consider the information submitted in order to determine whether *prima facie* evidence exists to justify the initiation of a sunset review.

Should the Commission decide to initiate a review, notice will be given in the *Government Gazette* and other parties, being exporters and importers of the subject products, will be requested to comment and provide information.
