Subject: Notification of the receipt of complaint for the initiation of an anti-dumping investigation on hot-rolled steel products in coils and not in coils originating in Japan, the Republic of South Africa, the Russian Federation, the Republic of Kazakhstan, the Republic of India, the Republic of Korea, Taiwan, the Bolivarian Republic of Venezuela, the Argentine Republic, Ukraine, the People's Democratic Republic of Algeria, the Republic of Indonesia, the Slovak Republic, and Romania.

Kindly refer to the Notification of the Committee on Dumping and Subsidy regarding the Final Determination of an Expiry Review of an Anti-Dumping Measure on hot-rolled steel products in coils and not in coils originating in Japan, the Republic of South Africa, the Russian Federation, the Republic of Kazakhstan, the Republic of India, the Republic of Korea, Taiwan, the Bolivarian Republic of Venezuela, the Argentine Republic, Ukraine, the People's Democratic Republic of Algeria, the Republic of Indonesia, the Slovak Republic, and Romania. B.E. 2564 (2021) dated 9th June B.E. 2564 (2021) and subsequent notifications.


