NOTICE FOR ORAL HEARING

Subject: Oral Hearing in the matter of Safeguard (Quantitative Restrictions) investigation concerning imports of Soda Ash into India

1. The Directorate has initiated Safeguard (Quantitative Restrictions) investigation concerning imports of Soda Ash into India on 16th March, 2026 under Foreign Trade (Development and Regulation) Act, 1992 and the Safeguard Measures (Quantitative Restrictions) Rules, 2012. As per Rule 6 (6) of the Rules, *“The Authorised Officer may allow an interested party or its representative to present the information relevant to investigation orally but such oral information shall be taken into consideration by the Authorised Officer only when it is subsequently submitted in writing.”*.
2. Accordingly, an oral hearing is scheduled to be held in online mode i.e., through Digital Video Conferencing (DVC). The details of the oral hearing are as follows:

 - e) Injury to Domestic Industry
 - f) Causal Link
 - g) Likelihood of Continuation or Recurrence of Dumping/Injury

- h) Non-Injurious Price (NIP)
- i) India Industry Interest
- j) Any Other Issues

Registered interested parties are advised to file their written submissions (Confidential Version and Non-Confidential Version) and rejoinders, if any, **only through the SETU Portal**, within the timeline announced by the Authorised Officer at the end of the hearing.
