**NOTIFICATION UNDER ARTICLE 12.1(A) OF THE AGREEMENT ON SAFEGUARDS
ON INITIATION OF AN INVESTIGATION
AND THE REASONS FOR IT**

Supplement

*Sweet and savoury biscuits of all kinds, industrially or mass produced,
and made primarily from wheat*

The following communication, dated 9 July 2026 and received on 30 July 2026, is being circulated at the request of the delegation of the Dominican Republic.

The Dominican Republic hereby notifies the Committee on Safeguards of the World Trade Organization that, on 9 July 2026, notice of Resolution No. CDC-RD-SG-020-2026, dated 8 July 2026, was published both in the national daily newspaper *El Caribe* and on the website of the Regulatory Commission for Unfair Trade Practices and Safeguard Measures (hereinafter the Trade Defence Commission or CDC) cdc.gob.do in the section on safeguard measure investigations¹, as part of the safeguard investigation into imports of sweet and savoury biscuits of all kinds, industrially or mass produced, and made primarily from wheat, its derivatives (wheat, wheat flour, with or without gluten), and those with ingredients that are rich in fibre or fibre-based, excluding artisanal biscuits, biscuits for babies, biscuits made from cereals other than wheat and its derivatives, and energy or nutrition bars, the main ingredient of which is not roasted wheat flour or fibre, classified under tariff subheadings 1905.31.90, 1905.32.00, 1905.90.10 and 1905.90.90 of the Seventh Amendment to the Customs Tariff of the Dominican Republic, from countries with which the Dominican Republic does not have a free trade agreement.

Under the Resolution, the Trade Defence Commission decided not to apply provisional safeguard measures, in determining that at this preliminary stage of the investigation, no critical circumstances had been identified where delay would cause damage to the domestic industry that would be difficult to repair, in accordance with the relevant provisions of the Agreement on Safeguards of the World Trade Organization and Law No. 1-02 on unfair trade practices and safeguard measures and its implementing regulations.

Nevertheless, a review of the information available at this preliminary stage shows that enough elements exist to continue the investigation and to deepen the analysis of the requirements set out in the Agreement on Safeguards and Law No. 1-02 and its implementing regulations, in order to determine whether or not adopting a definitive safeguard measure is appropriate.
