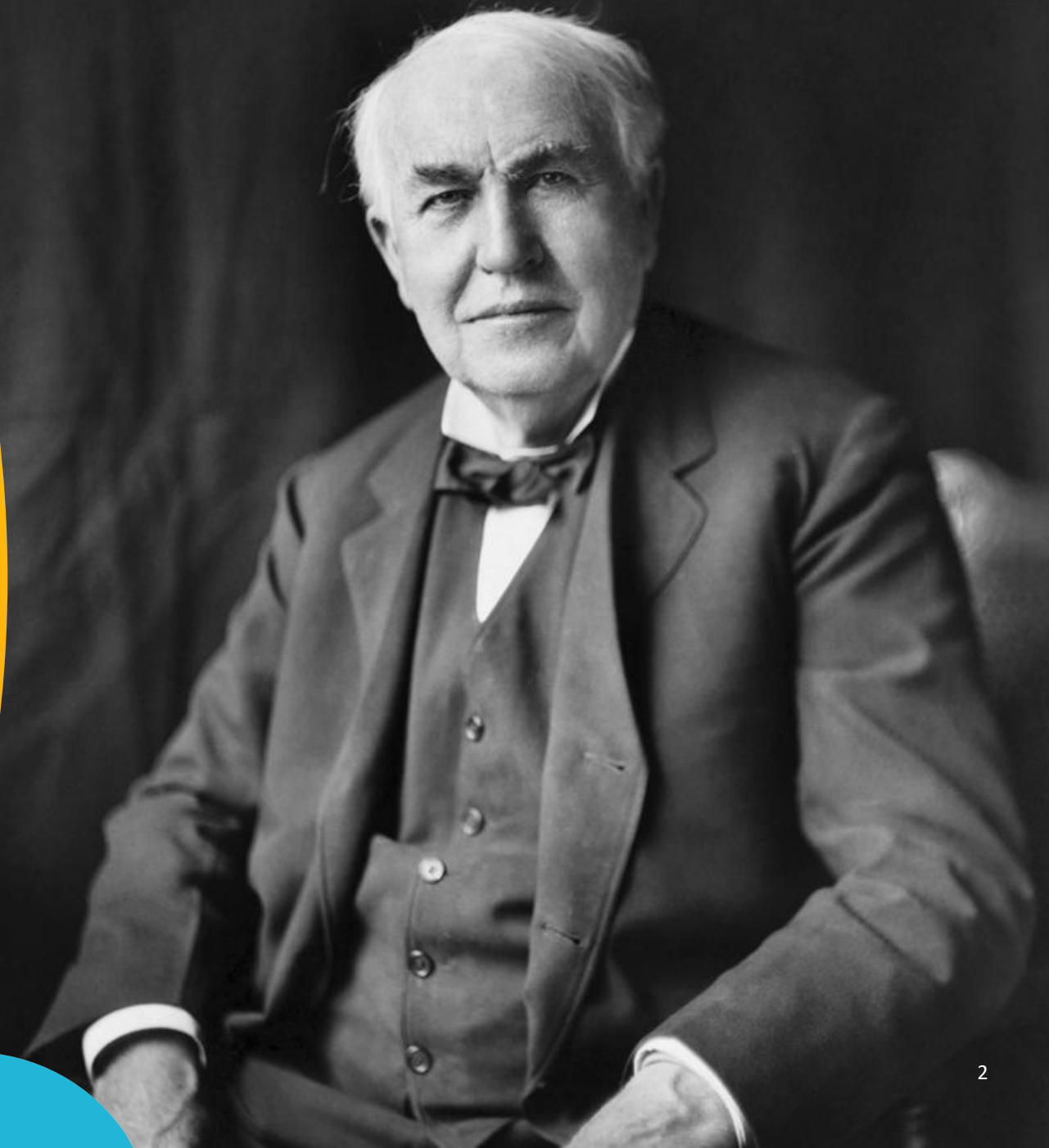

## 監管當局-沙烏地阿拉伯標準組織 Regulatory Authorities-SASO



### SASO致力於實現以下策略目標：

1. 制定與採用適當的商品服務標準，保障消費者安全。
2. 通過實施適當的沙烏地商品、產品和服務標準，促進國民經濟發展，提高國民產品的競爭能力。
3. 調整測量和校準的工具與程序，以配合國際測量和校準。
4. 在公營與私營機構的所有工業及服務活動中推廣優質文化並提高國民對採用優質標準的好處與認識。

### SASO works to achieve the following strategic goals:

1. Maintaining the safety of consumers through preparing and adopting suitable standards for goods and services.
2. Contributing to the development of national economy through the implementation of suitable Saudi standards on goods, products and services to improve the competitive capability of national products.
3. Adjusting tools and procedures of measurement and calibration in the Kingdom to match international measurements and calibration.
4. Disseminating the quality culture in all industrial and service activities, both public and private, and raising awareness of the benefits of adopting quality standards.

# 沙烏地阿拉伯 SALEEM THE INTRODUCTION FOR SALEEM



## 什麼是SALEEM計畫？

- SALEEM是對運往沙烏地阿拉伯的產品和貨物進行認證的新程序，其也被稱為沙烏地阿拉伯產品安全計畫。
- SALEEM計畫被列入2020年國家轉型計畫 (NTP)
- 新的SALEEM計畫旨在確保到沙烏地阿拉伯的商品和產品達到最高水平的安全標準，從而促進消費者的安全、環境保護與節能。

## What is SALEEM?

- SALEEM is the new Programme for the certification of products and shipments to KSA. It is also known as Saudi Product Safety Programme.
- SALEEM programme is included in the National Transformation Programme (NTP) 2020
- The new SALEEM Programme aims to ensure that goods and products imported into Saudi Arabia meet the highest level of safety standards thereby promoting consumer's safety, environmental protection and energy conservation.

# TECHNICAL REGULATION (TR) 技術法規

- 為法規內所管制之各類產品量身訂製的要求、標準以及符合性認證計畫的文件。
- 目前SASO已制定46個TRs，其中大部分已發布
- 目前SABER系統已經全面啟用，除部分化妝品沿用SASO流程外，其它產品都需要通過SABER系統獲得清關證書。
- 法規包含了各類術語、定義、包裝要求、標籤要求、生產流程要求和符合性認證計劃等等 (Type 1a, 3, 5)

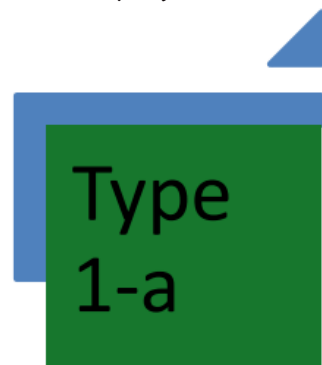

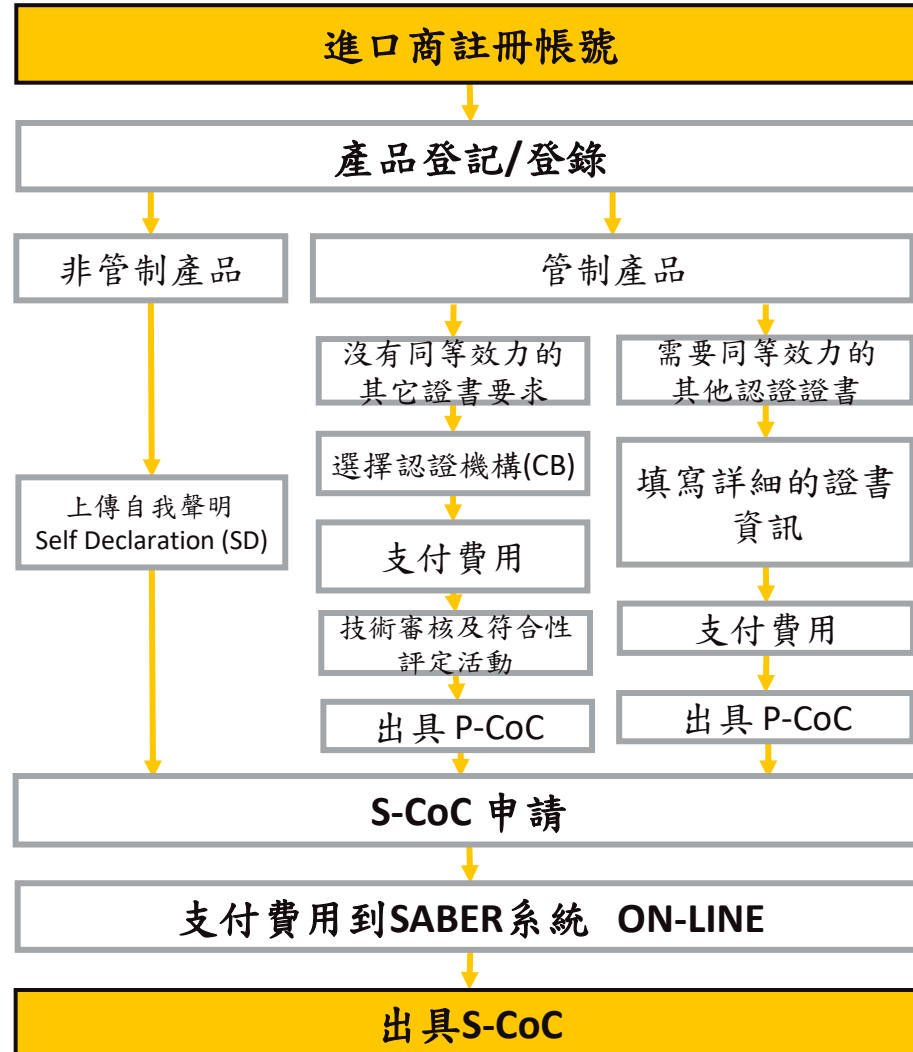

- ❑ 受管制的產品SCoC都由認證機構進行審核和批准

# Full Flow Chart of SALEEM 流程圖

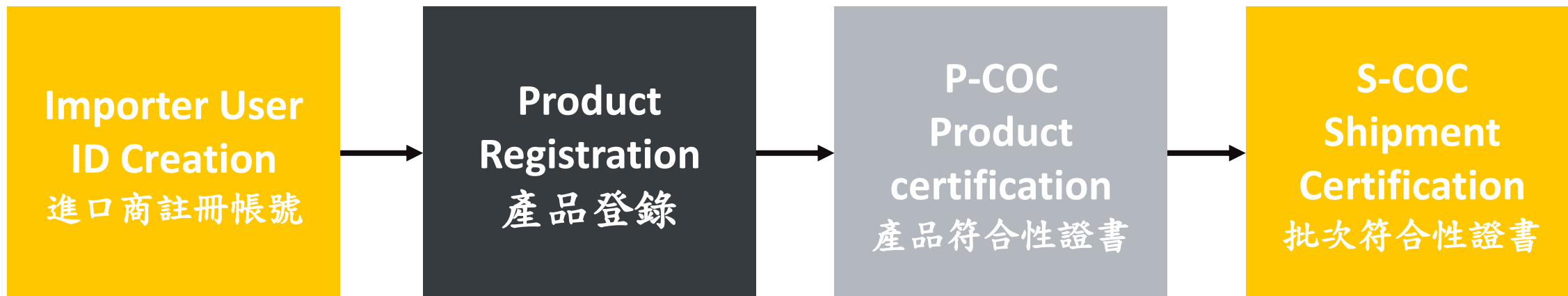

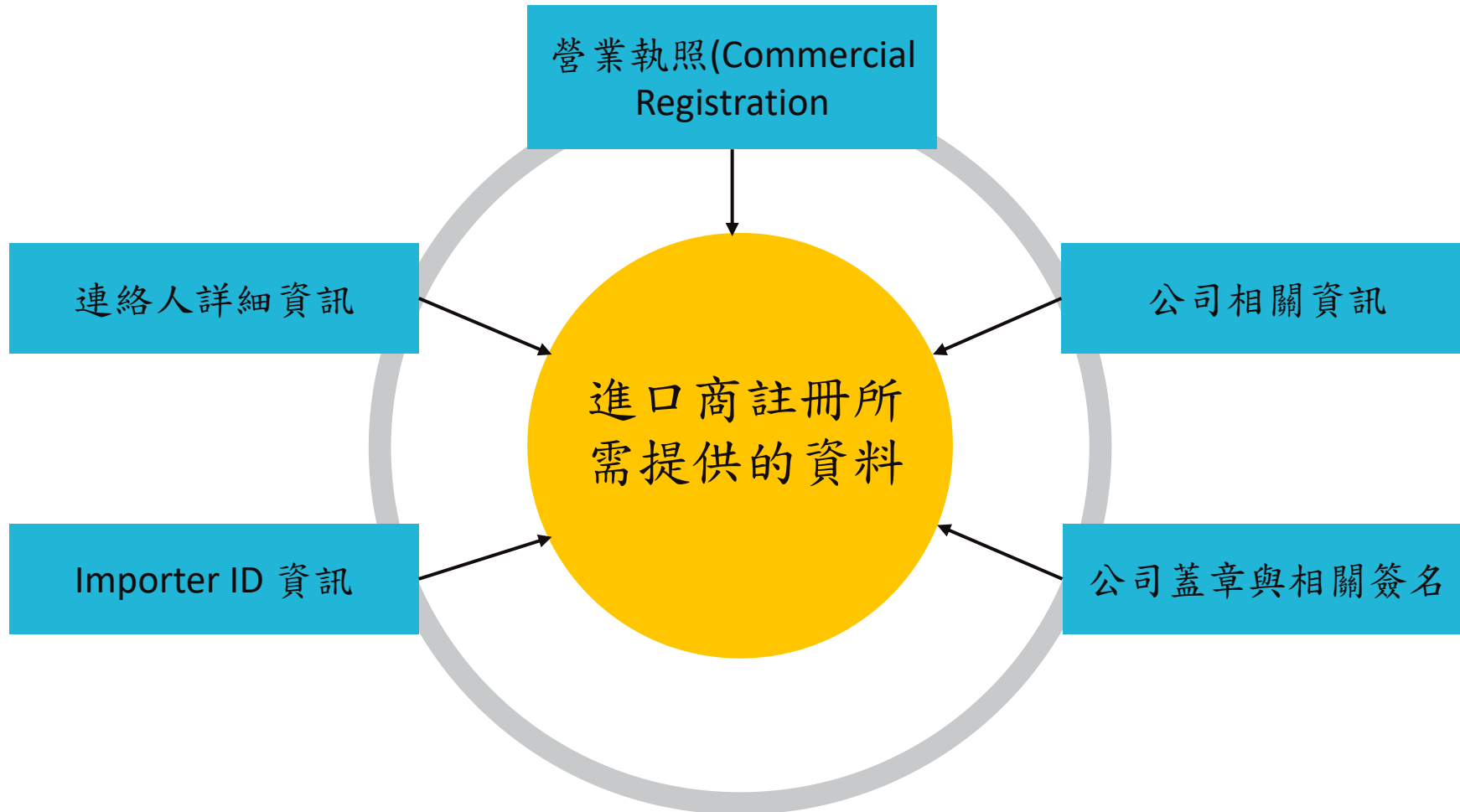

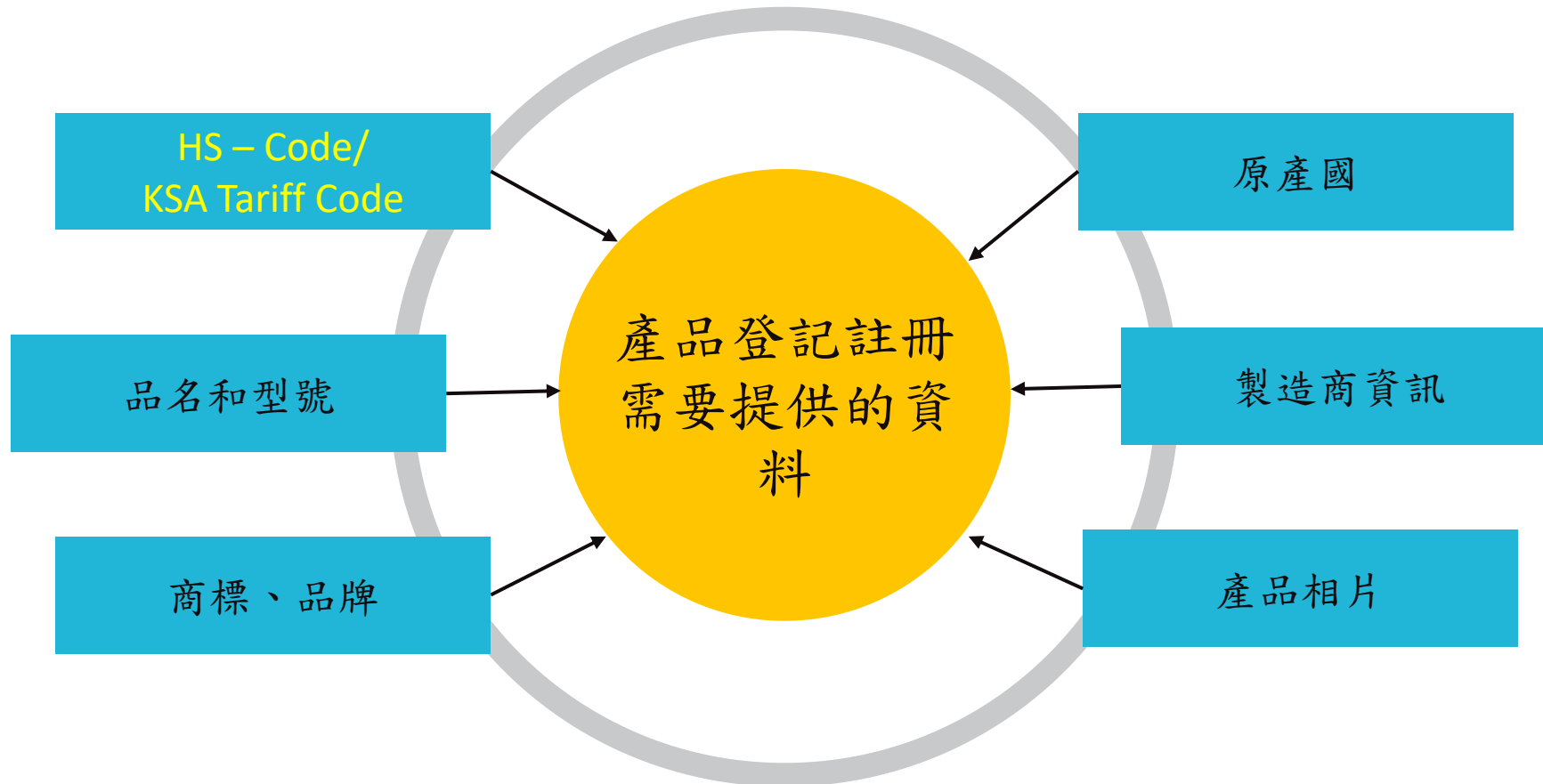

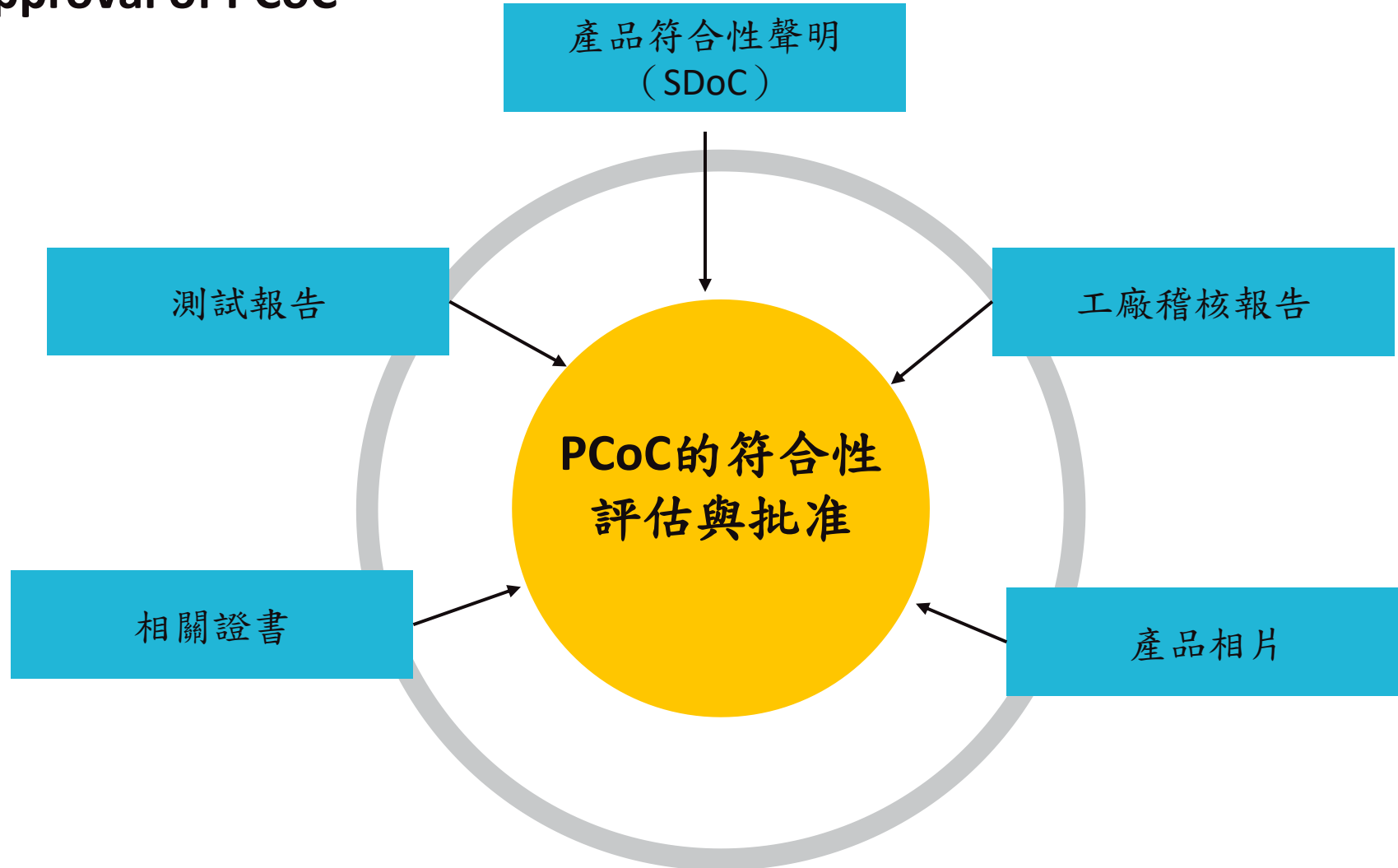

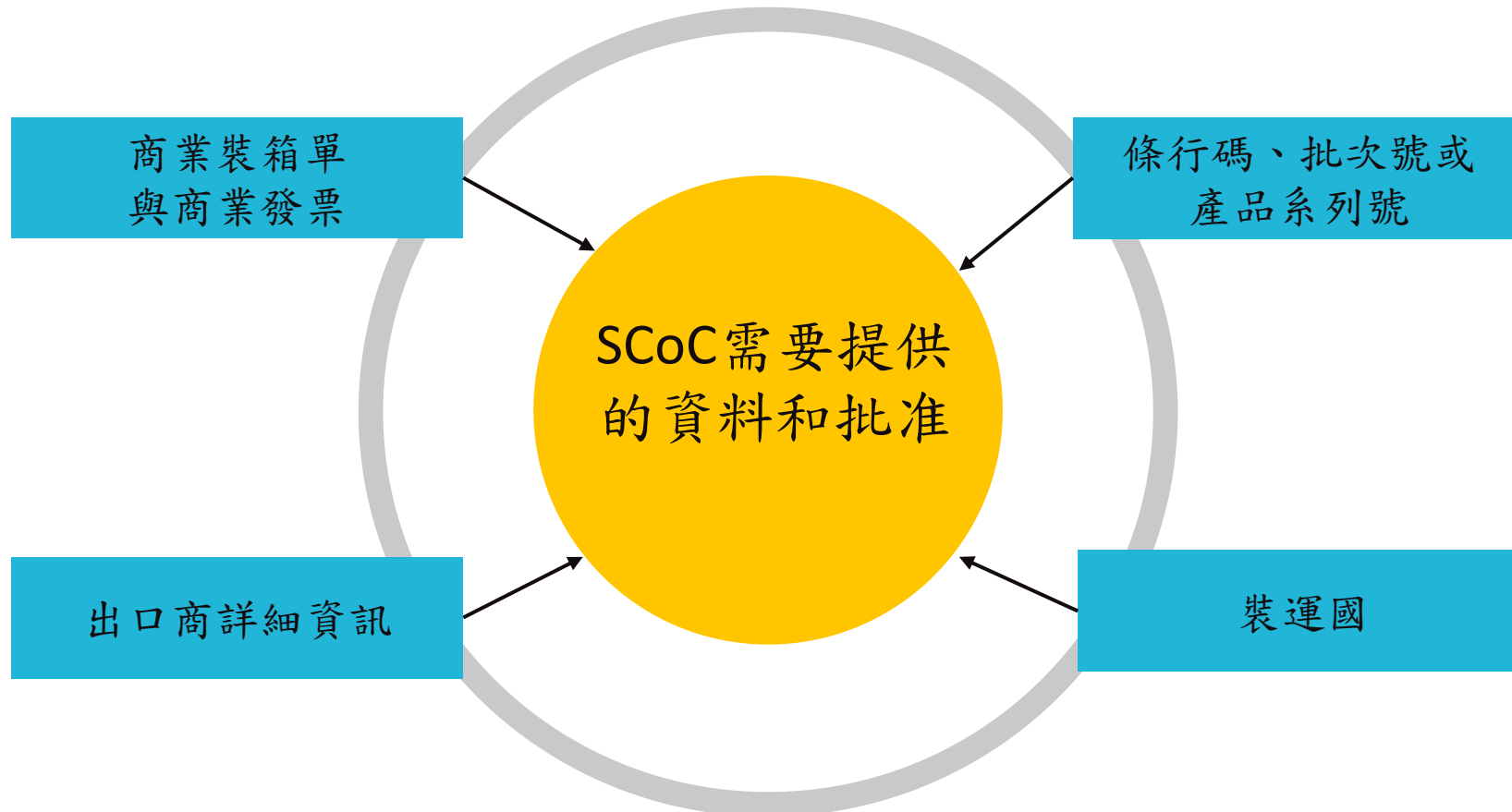

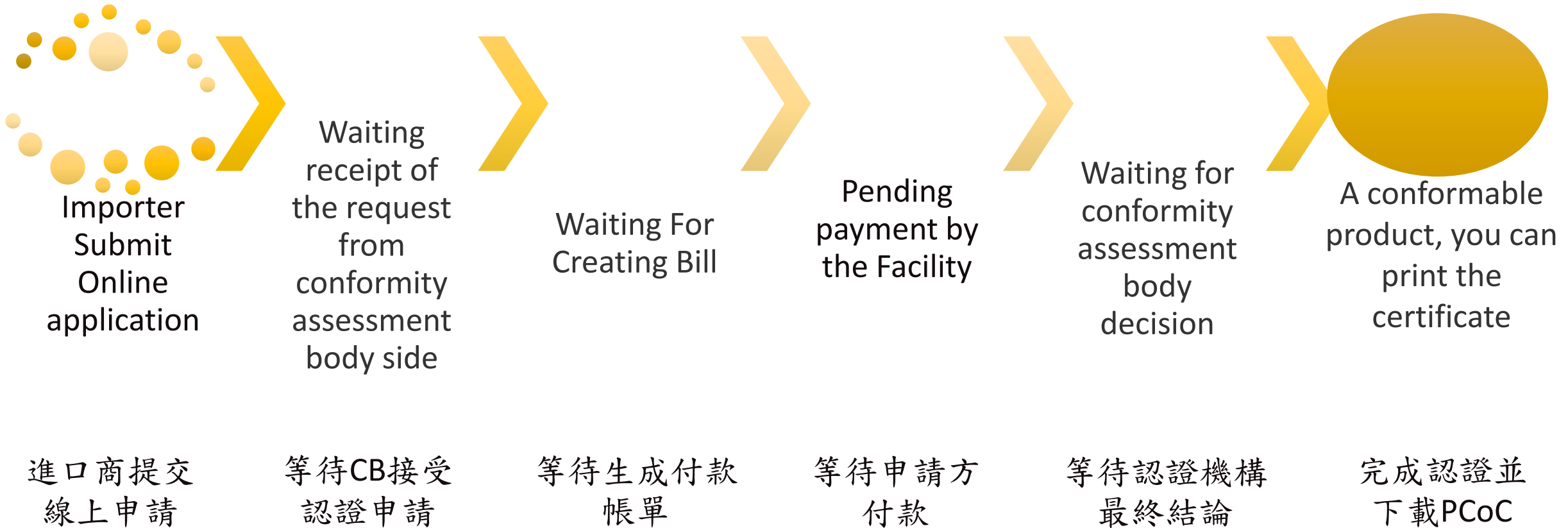



A delegated employee: The person who's authorised to represent an establishment and conduct transactions through Saber platform, including managing the establishment, managing the Electronic Identity records of the establishment's authorized representatives, granting authority to the establishment's authorized representatives, and managing the establishments electronic services.

#### Registration Requirements

- Commercial Registration number and expiry date
- ID number associated with the Commercial Register
- A copy of the manager's signature who's in charge of the establishment
- Copy of the establishment stamp
